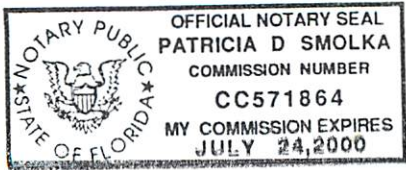

PROPOSED AMENDMENT TO THE  
DECLARATION OF NEIGHBORHOOD COVENANTS  
FOR GEORGETOWN AT EAGLE TRACE

(additions indicated by underlining, deletions by "----",  
and unaffected language by ". . .")

*To revise the maintenance obligations of the Association and the Membership relative to the mailboxes in front of the homes, so that the Association is responsible for the maintenance, repair and/or replacement of the mailboxes, a change to Section 4 of Article II of the Declaration is as follows:*

ARTICLE II

SUPPLEMENTAL RESTRICTIONS

. . .

4. GARAGES, CARPORTS, TRASH AREAS, MAILBOXES.

. . .

d.) The design, material and location of all mailboxes must be approved by DECLARANT prior to installation. DECLARANT shall have the right and power to select a uniform style and/or brand of mailbox for use in the NEIGHBORHOOD and upon such selection all OWNERS shall only use the uniform mailbox selected by DECLARANT. All mailboxes shall be maintained by the Association, as a common expense of the Association, in good, clean, and attractive condition as required by DECLARANT.
