ASSIGNMEN'T OF DECLARANT'S ENFORCEMENT RIGHTS

WITNESSETH:

WHEREAS, Florida National Properties, Inc., is the "Declarant" named in that certain DECLARATION OF NEIGHBORHOOD COVENANTS FOR GEORGETOWN AT EAGLE TRACE ("Declaration") dated the 10th of November, 1988 and recorded in Official Records Book 15949, at Page 0735, of the Public Records of Broward County, Florida and encumbering the property described as all of Georgetown at Eagle Trace, according to the Plat thereof, as recorded in Plat Book 134, at Page 44, of the Public Records of Broward County, Florida, said land situate, lying and being in the City of Coral Springs, Broward County, Florida; and

WHEREAS, Declarant has heretofore been granted the right and power of enforcement of certain restrictive covenants set forth in the Declaration, the right and power to approve certain plans for improvements constructed upon properties encumbered by such Declaration, and the right and power to assess properties encumbered by the Declaration; and

WHEREAS, WCI Communities Limited Partnership, a Delaware limited partnership (hereinafter referred to as "WCI") is the successor by merger of Florida National Properties, Inc., and has succeeded to all of the powers and duties of the Declarant; and

WHEREAS, The GEORGETOWN AT EAGLE TRACE ASSOCIATION, INC., a Florida not-for-profit corporation ("NEIGHBORHOOD ASSOCIATION") is the Neighborhood association for the property subjected to the Declaration; and

WHEREAS, transition of control of the Neighborhood Association has occurred and the Neighborhood Association is now under the control of the owner-elected Board of Governors; and

WHEREAS, the Neighborhood Association is desirous of having the authority and power to enforce restrictions and covenants set forth and described in the Declaration and has requested WCI to assign to the Neighborhood Association Declarant's right, interest, powers and duties under the Declaration; and

WHEREAS, the Neighborhood Association by and through its duly elected Board of Governors is ready and willing to take over the enforcement and approval rights and powers from WCI; and

WHEREAS, WCI is desirous of assigning to the Neighborhood Association, its enforcement and approval rights reserved in the Declaration.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable considerations, the receipt and sufficiency of which are acknowledged, Declarant and the Neighborhood Association hereby agree as follows:

- 1. The above recitals are true and correct including the recitation of considerations and are incorporated herein by reference
- The Declarant hereby assigns to the Neighborhood Association all of its enforcement, approval, assessment rights, powers, interest and obligations in, to and under the Declaration.
- Upon execution this Assignment shall be recorded in the Public Records of Broward County, Florida.
- This Assignment shall be construed according to the laws of the State of Florida.
 In the event legal action shall become necessary, venue shall be in Broward County, Florida.
- 5. The Board of Governors of the Neighborhood Association does hereby accept this Assignment for and on behalf of the Neighborhood Association by and through its duly authorized officers, and by the authority and powers vested in them by and through the Articles of Incorporation and By-laws of the Neighborhood Association and in accordance with said Articles and By-laws; and does hereby waive, release and relinquish Declarant, and WCI from any and all claims, demands, choses, or rights of action it has or may have against WCI, jointly and/or severally, concerning, related to, arising from, or growing out of the enforcement and approval duties, powers, rights and obligations under, by and through, the Declaration from the date of their inception to the date of these presents.
- 6. The Board of Governors of the Neighborhood Association acting on behalf of the Neighborhood Association acknowledges and agrees that upon execution of this Assignment, Declarant shall not be liable or responsible for, in any manner whatsoever, the actions of the Neighborhood Association, its successors or assigns hereunder.
