NOTICE OF STATEMENT OF MARKETABLE TITLE

This Resolution is made and entered into this 21st day of May, 2013, by the Board of Governors of EAGLE TRACE COMMUNITY ASSOCIATION, INC. The meeting was called to order on May 9, 2013, which meeting was properly noticed pursuant to the Bylaws of the Eagle Trace Community Association, Inc., and in accordance with Chapters 712 and 720, Florida Statutes, at which meeting a quorum of the Board of Governors was in attendance, the following resolution was proposed and passed:
